# 『計量經濟學』に關する主要文獻

別稿『計量經濟學の最近の發達について』述べた如く、經濟學に於ける理論的數量的研究は、それが正しく行はれる限り、當然、經驗的數量的研究と一致すべき筈のものである。従つて兩者の綜合を目ざす『計量經濟學的研究』と正しい意味に於ける理論經濟學的研究とは、本來同一のものであり、理論經濟學に關する主要文獻目錄を作成することは、同時に、『計量經濟學』に關する主要文獻目錄を作成することとなる筈である。しかしかくの如くに考へてくると、本文獻目錄は餘りにも尨大なものとなり、限られたスペースにこれを盛ることはできないから、ここでは單に(一)理論的數量的研究と經驗的數量的研究との綜合を何等かの意味に於て現に遂行してゐる論策または(二)かかる綜合の可能性を論證することを以てその主題とする論策乃至(三)前二類に關する紹介考察乃至批評を主題とする論策を、列擧するに止める。

この種の研究は、既に別稿に於て論じた如く、微視的研究及び巨視的研究並びに兩者の綜合の三分野に分れるが、ここでは便宜上後の二つを一括して第三項『巨視的研究』に收め、別に總說的なるものを集めて第一項『一般的研究』

『計量經濟學』に關する主要文獻

に收め、これらのいづれにも屬し難き特殊的研究を第四項『その他』に入れる。

次に第二項『微視的研究』は、別稿にも述べた如く、現在までの成果からみれば、社會的需要法則の數量化、社會的供給法則の數量化、個別的需要法則の數量化、費用曲線の數量化及び限界效用の測定に分つを得よう。(但しこれらの研究のうち社會的需要法則の數量化については、學界に於て最も古く論ぜられ、その文獻も甚だ多量に上る。しかし幸にして、この部分に關してのみは、左記の文獻目録があり、それぞれその刊行年以前の文獻を載せてある。
