

BIBLIOGRAPHY ON ECONOMICS PUBLISHED IN JAPAN IN WESTERN LANGUAGES, 1956-1958

Compiled here is a bibliography of books and articles in *western languages* in various fields of economics that were published *in Japan* during 1956-1958. It constitutes a sequel to the similar list for 1945-1955 which was made public in *Japan Science Review, Economic Sciences*, No. 3, 1956. As in the case of the earlier list, this bibliography is the work of the Library staff of the Institute of Economic Research, Hitotsubashi University under the supervision of Mr. Fukumaru Aso.
